## **Qualification Overview and Objective:**

The Britsafe Level 2 Award in Wind Turbine Safety Rules is a sector-specific qualification tailored for personnel engaged in wind turbine installation, operation, or maintenance activities. It equips learners with a clear understanding of safety protocols, turbine-specific hazard controls, and structured emergency procedures essential for work at height and within confined turbine structures. The objective of the qualification is to support regulatory compliance, reduce operational risks, and ensure that workers demonstrate safety-critical competence in accordance with industry-aligned wind turbine safety rules.

The objective of the qualification is to:

- Understand the specific safety rules and considerations for wind turbine operations.
- Identify and assess hazards and risks associated with wind turbine activities.
- Learn effective strategies for safe working in and around wind turbines.
- Gain knowledge of emergency response and evacuation procedures in wind turbine environments.
- Demonstrate compliance with legal requirements for wind turbine safety.

#### **Entry Requirements:**

To register for this qualification, learners are required to meet the following entry requirements:

- Must be aged 16 and over
- Participants should have a basic understanding of the English language to effectively engage with course materials and assessments.
- This course is open to individuals of all backgrounds and experience levels who have an interest in workplace health and safety.

#### **Geographical Coverage:**

This qualification is suitable for delivery in England, Northern Ireland, Wales and can be offered internationally.

#### **Delivery/Assessment Ratios:**

To effectively deliver this qualification, centres are recommended not to exceed the ratio of 1 Qualified Tutor to 12 Learners in any one instance. If centres wish to increase the recommended ratio, they must first inform your dedicated Britsafe™ accounts manager before doing so.

#### **Centre Requirements:**

To effectively deliver this qualification, centres should have the following resources in place:

- Classroom with suitable seating and desks; and
- High-quality teaching and learning resources.

#### **Guidance on Delivery:**

The total qualification time (TQT) for this qualification is 8-hours and of this 8-hours is recommended as guided learning (GL). TQT is an estimate of the total number of hours it would take an average learner to achieve and demonstrate the necessary level of attainment to be awarded with a qualification, both under direct supervision (forming Guided Learning Hours) and without supervision (all other time). TQT and GLH values are advisory and assigned to a qualification as guidance.



#### **Guidance on Assessment:**

This qualification is assessed through a multiple-choice question exam.

- Centre's must take all reasonable steps to avoid any part of the assessment of a learner (including any
  internal quality assurance and invigilation) being undertaken by any person who has a personal interest
  in the result of the assessment.
- Centres must follow Britsafe<sup>™</sup> Examination and Invigilation Procedures. Completed examination papers
  are to be returned to BritsafeTM for marking or If in case of online examination; records shall be updated
  on EMS portal accordingly.


#### **Guidance on Quality Assurance:**
